Gentlemen:

We reply to your request for clarifications on the news article entitled "MM subway project cutter head arrives" posted in Daily Tribune (Online Edition) on May 29, 2019.

"The cutter head of the tunnel boring machine (TBM) for the Metro Manila Subway Project has arrived, putting to rest public apprehension or even doubt that the ambitious project is a mere pipe dream.

A Daily Tribune source in the Department of Transportation said that the arrival of the TBM cutter is a definitive step towards the North-South Commuter Railway starting in the fourth quarter of this year.

Upon Transportation Secretary Arthur Tugade's prodding on DMCI to fast-track the same, the project completion eyed originally for 2022 has been accelerated to 2021.

DMCI committed to advance the completion without sacrificing the quality of the project under the Duterte administration's Build, Build, Build Program."

We wish to confirm / clarify the following:

The Tunnel Boring Machine (TBM) featured in The Daily Tribune is for the Metro Manila Subway Project, in which D.M. Consunji, Inc. (DMCI) has no involvement.

DMCI, however, is involved in the construction of the Phase 1 of the North South Rail Commuter (NSCR) Project, as disclosed to the PSE last May 21.

While DMCI is committed to completing the NSCR Phase 1 project as soon as possible, and in accordance with strict quality standards, it is unable to confirm a 2021 completion date this early in the project.
